

St. James' Episcopal School is a diverse, joyful, and inclusive community of learners. With a focus on academic excellence and attention to the needs of each child, we strive to instill in our students intellectual curiosity, compassion for others, and respect for all of God's creation.

The following pages reflect those individuals and families who have given generously to St. James' Episcopal School in the 2019–2020 school year. We are so grateful to each and every one of you.

Letter from Head of School

Dear St. James' Community,

The past year was not easy for our school or for our society. Yet, St. James' came together as a community to support one another through a very challenging spring, summer and fall. We are enormously grateful that over 500 donors supported St. James' this past year, giving to the Every Child Fund, our irst ever virtual gala and to the several friendraising activities that the school engages in throughout the year. 2019-2020 was a historic year for generosity, over \$1 million was raised to support St. James'. These gifts meant that as families faced unforeseen challenges with regard to Covid-19, the school was able to expend over \$100,000 in additional tuition assistance; as we shifted rapidly to remote instruction, we had the resources to build a virtual program, hire more teachers and begin to build a hybrid model of a bring your own device and a 1:1 (school assigned) computer program. We also refined the preschool curriculum, adding daily science and a Spanish language program; and laid the groundwork for the greening of St. James' with a new composting program (to be launched in the winter of 2021).

Excitingly, due the generosity of this extraordinary community we have also been able to accelerate the school's plan to shift to a 1:1 model for all enrolled K-6 students --3 years early! We will also launch a K-6 robotics program later this fall, a year ahead of schedule.




